### CJV Working & Tracking:

- The Trump Administration created a new Faith Office under the direction of Pastor Paula White, who has for years been the President's religious advisor and who directed the Office of Faith Engagement during his first term. Rabbi Menken was invited to the White House for the founding reception for this new office.
- The Administration has created a Task Force to Eradicate Anti-Christian Bias. Unlike the Antisemitism Task Force created within the Department of Justice, this one focuses primarily upon anti-Christian policies, practices, or conduct by federal agencies. As many of these policies oppose Biblical values and religious freedom overall, we anticipate the work of this task force will benefit the Jewish community and all Americans.
- On Feb. 5 CJV Missouri held its second annual 'Day of Advocacy' at the Missouri State Capitol. A wide cross-section of Orthodox and allied advocates were represented in support of our mission. CJV had 6 official meetings with legislators, many of whom represented the House and Senate leadership, as well as informal meetings and introductions with other influential legislators.
- In addition to Oklahoma Statewide Charter School Board v. Drummond (see JTA coverage above), the Supreme Court is also to hear Mahmoud v. Taylor, a parental rights case. The Montgomery County, MD School District initially allowed religious parents to opt-out of LGBTQ story books for their children, but then changed its mind to neither notify parents when such books would be read, nor allow excused absences for their children. It is a straightforward case of agenda-driven indoctrination in the public school system, and CJV is likely to file an amicus brief in this case as well.
