Witness helped the Government with their sting operation in the Rabbi Mendel Epstein investigation, which resulted in a successful prosecution.

Witness has access to current Ohel residents; one, in particular, comes to her home for the Sabbath.

History: Witness successfully recouped a large sum of money that Ohel illegally withheld from forty families of disabled children under the Medicaid Waiver Program. Witness described a "pattern of lies and deceit" as well as "constant stonewalling" in her interactions with Ohel's executive director David Mandel who tried to steal this money that was designated for these 40 families of disabled children. Ohel used the names of those families to obtain the funds in the first place. This case was from a number of years ago but the paperwork shows Ohel's attempted theft of substantial federal funds (subsidies for 40 families).

FRAUDULENTLY STRUCTURED BUDGET FOR LIFETIME CARE FOUNDATION — Ohel purportedly invests the money of this pooled trust in their own investments and doesn't appropriate the funds to the residents' needs.

COLLUSION WITH SHALOM TASK FORCE OF NEW YORK (recipient of federal awards from DOJ for civil legal services for domestic violence victims in the Orthodox community)

Audit found that Shalom Task Force, "lacked drawdown procedures, charged the awards based on estimated personnel expenses, did not adequately monitor consultants and contractors, submitted inaccurate financial reports, and did not comply with all of the award special conditions."

Witness can show a pattern of Shalom Task Force wreaking havoc with families (using lawyers and social workers) so as to generate cases for Ohel, which in turn generates consultations/caseloads for Shalom Task Force. Witness will provide specific cases/witnesses. These practices observed by witness seem to conform to the audit findings against Shalom Task Force. Witness has identified a staff attorney at Shalom Task Force who is also one of Ohel's largest donors. This same staff attorney/Ohel donor purportedly suborned perjury by threatening an innocent mother and lying to the mother's therapist: see The Shonda Report, pg. 67. (This occurred circa 10/2021).

Witness also saw parents of disabled children pressured to do fundraising for Ohel. In one case, once the parents were no longer able to fundraise, their adult disabled child was shifted out of his apartment under Ohel's auspices and "demoted" to a group home with 12 residents on the floor. The name of that resident is Eli Zdanowitz

POSSIBLE KICKBACKS FROM POMEGRANATE PREMIER KOSHER FOOD SUPERMARKET

Witness saw a repetitive pattern of Alex Mintz's purchasing of spoiled and expired food from this exclusive food emporium. Since Ohel's budget provides for safe food at market value, the purchase of expired food from this premier supermarket may involve a kickback to Ohel since the clientele who shop at Pomegranate are discerning shoppers and therefore would not be buying expired food items. The food that would ordinarily be discarded would then be sold to Ohel in a kickback arrangement. (Employees working under Mintz years ago told EDNY of his instructing his staff to use residents' own food stamps to buy food for Ohel's office staff meetings –photographic evidence was supplied at that time.)
